

Cardblastshow LLC — Guest & Attendee Policy (New York)

1. Purpose

This Guest & Attendee Policy applies to all individuals attending any trading card and collectibles event operated by **Cardblastshow LLC** (“the Show”).

Entry to the Show constitutes agreement to this Policy and all instructions issued by Show staff or venue personnel.

Cardblastshow LLC’s goal is to provide a safe, enjoyable, and professional environment for collectors, vendors, families, and enthusiasts.

2. Admission & Entry

- Admission, wristbands, and tickets are **non-transferable** and **non-refundable**, except where required by law.
- Re-entry may require proof of admission.
- Cardblastshow LLC reserves the right to deny entry or remove any attendee who violates this Policy or creates a disruption.

Entry to the Show is a privilege, not a guarantee.

3. Behavior & Conduct

All attendees must behave respectfully and responsibly.

Prohibited behavior includes:

- Harassment, threats, intimidation, or bullying
- Fighting or disorderly conduct

- Disrupting vendors, staff, or other attendees
- Offensive, abusive, discriminatory, or hateful speech
- Damaging property or tampering with displays

Attendees must follow any instruction given by Show staff or security.

Violations may result in **removal without refund** and potential law enforcement involvement.

4. Trading, Buying & Selling

- Personal trading is allowed **only** if it does not block aisles, disrupt vendors, or resemble unauthorized vending.
- Unauthorized selling or setting up displays without approval is prohibited.
- Cardblastshow LLC is **not a party** to trades or sales between attendees.

All trades and purchases are at the attendee's own risk.

Disputes between collectors must be handled privately unless law enforcement is necessary.

5. Prohibited Items & Activities

The following are strictly prohibited:

- Illegal drugs or controlled substances
- Alcohol except in areas expressly permitted by the venue
- Gambling or games of chance
- Counterfeit, stolen, or fake merchandise
- Weapons or items reasonably perceived as dangerous (unless otherwise permitted by venue and law)
- Outside signage, displays, or soliciting without approval

- Any illegal or unsafe activity

Any prohibited items may be confiscated and the attendee may be removed from the Show.

6. Bag Checks & Security

For safety reasons, **bags may be inspected** at entry or during the event.

Refusal to comply may result in denial of entry.

Security staff and law enforcement may be present.

7. Children & Minors

- Children must be supervised at all times.
- Parents/guardians are responsible for the conduct and safety of minors in their care.

Cardblastshow LLC is not responsible for unsupervised children.

8. Merchandise Authenticity

Cardblastshow LLC does not guarantee the authenticity of items bought, sold, or traded at the Show.

Attendees are responsible for verifying authenticity before purchasing or trading.

9. Lost, Stolen, or Damaged Property

Attendees are responsible for safeguarding their belongings.

Cardblastshow LLC, the venue, and Show staff are **not liable** for:

- Lost or stolen property
- Cards, collectibles, or personal items
- Damage to items brought into the Show

Lock valuables, remain aware, and report suspicious activity immediately.

10. Photography, Video & Media

By entering the Show, attendees grant Cardblastshow LLC permission to:

- Photograph, film, or record them
- Use their likeness in promotional or marketing materials
- Publish images or recordings online or in print

Attendees who object must notify Cardblastshow LLC **in writing prior to entry**.
Unauthorized commercial filming requires approval.

11. Health, Safety & Emergencies

Attendees must comply with:

- Venue safety policies
- Fire regulations
- Any posted health requirements (if applicable)

In an emergency, follow staff instructions and exit calmly.

12. Refunds, Rescheduling & Event Changes

Tickets and admission fees are **non-refundable**.

If the Show is postponed, relocated, or rescheduled due to circumstances beyond Cardblastshow LLC's control (including weather, venue closures, safety concerns, or government orders), tickets will transfer to the rescheduled date. **Cash refunds are not guaranteed.**

Cardblastshow LLC may modify floor layouts, hours, or programming when necessary.

13. Assumption of Risk & Liability Waiver (New York Compliant)

By entering the Show, attendees acknowledge and agree:

- Participation involves inherent risks (crowds, activity, potential accidents, exposure to illness).
- Attendance is voluntary and at their own risk.
- Cardblastshow LLC, the venue, owners, employees, volunteers, and contractors are **not liable** for injury, loss, or damages, **except as required by New York law.**

Attendees agree to **release and hold harmless** Cardblastshow LLC from claims arising out of attendance at the Show.

This Policy does **not** waive rights regarding gross negligence or intentional misconduct, which cannot legally be waived.

14. Indemnification

Attendees agree to indemnify and hold harmless **Cardblastshow LLC** from claims or damages arising from:

- Their actions or conduct
- Damage they cause to property or others
- Violations of this Policy

15. Disputes & Legal Venue (New York)

Any complaint or incident should be reported to Show staff **promptly**.

If a dispute cannot be resolved informally:

- This Policy is governed by the laws of the **State of New York**.
- Any legal action must be filed in a court of competent jurisdiction within **New York State** (county designated by Cardblastshow LLC).

Cardblastshow LLC may require **mediation** before litigation.

16. Non-Disparagement During Active Disputes

Attendees agree not to knowingly publish false or defamatory statements regarding Cardblastshow LLC, vendors, or staff while a dispute is under review.

This does not restrict lawful reporting or honest reviews.

17. Removal & Enforcement

Failure to comply with this Policy may result in:

- Denial of entry
- Removal without refund
- Possible ban from future events
- Notification of law enforcement when appropriate

Enforcement decisions are at the discretion of Cardblastshow LLC and venue security.

18. Agreement

By entering the Show, the attendee:

- Confirms they have read or been made aware of this Policy,
- Agrees to comply with all rules,
- Understands the risks involved, and
- Accepts that violations may result in removal without refund.
