

Cardblastshow LLC — Privacy Policy

This Privacy Policy explains how **Cardblastshow LLC** (“we,” “our,” or “the Show”) collects, uses, and protects personal information from guests, attendees, vendors, and website visitors.

By attending the Show, purchasing tickets, registering as a vendor, or interacting with us online, you agree to this Policy.

Our goal is to respect your privacy while operating a safe, secure, and enjoyable trading card & collectibles event.

1. Information We Collect

We may collect the following types of information:

A. Information You Provide

- Name
- Email address and phone number
- Mailing address (if provided)
- Ticket purchase details
- Vendor registration information
- Incident reports or customer service inquiries

B. Payment Information

Ticket and vendor payments are processed through secure third-party processors.
Cardblastshow LLC does not store full credit card numbers.

C. Event & Security Information

To help maintain safety and event operations, we may collect:

- Security camera footage (where installed)
- Entry verification logs
- Incident or accident reports
- Lost-and-found claims

D. Photography & Media

Photos and video may be captured at the Show for marketing and documentation.

E. Website & Technology Data

When you visit our websites or ticket platforms, we may automatically collect:

- IP address
- Browser/device type
- Pages visited
- Cookies or similar tracking data (where applicable)

This helps improve event planning, marketing, and security.

2. How We Use Information

We use information to:

- Process ticket and vendor registrations
- Communicate event updates and confirmations
- Maintain safety, security, and crowd management
- Resolve disputes and respond to incidents
- Improve future shows and customer experience

- Send marketing emails (you may unsubscribe at any time)
- Comply with legal and venue requirements

We do **not** sell personal information.

3. Photography, Video & Recordings

By attending the Show, you acknowledge that:

- Photos and video may be taken by Cardblastshow LLC
- Your likeness may appear in marketing, social media, or promotional materials
- Media captured becomes the property of Cardblastshow LLC

If you object to being photographed, notify staff at entry — we will make reasonable efforts but cannot guarantee exclusion from all wide-angle or crowd shots.

4. Sharing of Information

We may share limited information when necessary with:

- Event venue/security
- Ticketing and payment processors
- Insurance providers (if claims occur)
- Legal authorities when required by law
- Email or marketing service providers
- Emergency services during safety incidents

Vendors **do not receive attendee data** unless you choose to share your information with them directly.

We do not sell attendee lists.

5. Data Security

We use reasonable administrative, physical, and technical safeguards to protect information. However, no system is 100% secure, and attendees share information at their own risk.

6. Data Retention

We retain information only as long as reasonably necessary for:

- Event operations
- Dispute or incident resolution
- Legal, accounting, or safety obligations

Security footage and incident reports may be retained longer where required.

7. Children & Minors

Our events are family-friendly, but we do not knowingly collect personal information from children under **13** without parental involvement.

Parents/guardians are responsible for supervising minors at the Show.

8. Third-Party Websites & Links

Our sites or communications may link to third-party services (for example, ticketing platforms). We are not responsible for the privacy practices of those services. Review their policies before providing information.

9. Your Choices

You may:

- Unsubscribe from marketing emails
- Request correction of inaccurate information
- Ask for clarification about how your data is used

10. Law Enforcement & Safety

Cardblastshow LLC may disclose information if reasonably necessary to:

- Protect attendee and staff safety
 - Investigate fraud, theft, or criminal behavior
 - Comply with lawful requests, subpoenas, or court orders
